

#### FINANCIAL OVERVIEW: STATE OF THE BUDGET

- This year: \$1 million deficit
- Next year: Drop below 17% reserve level
- In 3 years: Reserves depleted
- In next 5 years, deficits of \$1.15 to \$3.4 million
- By FY 2023/24, cumulative deficit projected at \$5.8 million


The City is in a fiscal emergency.

Without course correction, the City will be forced to make significant cuts.




#### UNDERSTANDING OUR REVENUES

- Heavily reliant on sales and TOT taxes (50% of budget)
- Property Tax \$1.5 million
  - Scotts Valley collects 6.5% (for \$5,000 tax bill, Scotts Valley receives \$325)
  - Santa Cruz 16%
  - County 13%





### PROPERTY TAX ALLOCATION



Nearly \$23 million in annual property tax is collected in Scotts Valley. Of that, the City receives \$1.5 million.

- Reduced staff by 20%



Of the total 9.00% sales tax collected in the City of Scotts Valley, the City government receives 1.50%.


That is equal to 1½ cents for every dollar spent.

## LOCAL SALES TAX RATE CHANGE PROPOSAL: MARCH 2020 BALLOT (MEASURE Z)

- Eliminate existing ½ cent sales tax and replace with 1¼ cent
  - Net increase of ¾ cent for new rate of 9.75%
  - = 38 cents on a \$50 dinner. 75 cents on a \$100 purchase.
- Would raise \$2 million more.
- NO operational cuts would be needed. Preserves core services
- Duration of 12 years to weather the most difficult times
- Considerations: Keeps sales tax for use in Scotts Valley. Nonresidents pay sales tax.

#### City of Scotts Valley Fiscal Emergency and Measure Z

In early December, the City Council declared a Fiscal Emergency in the City of Scotts Valley and placed a ballot measure, Measure Z, on the March 2020 ballot to increase the local sales tax.

The City is asking Scotts Valley voters to raise revenues to avoid deep cuts and maintain core city services, such as our local police force and dispatch, street, storm drain and park maintenance, emergency preparedness, and other general services.

The City is in an unstable financial condition due to growing projected deficits that range from \$1 million to \$3 million annually. To meet the gap, the City projects drawing down its safety-net reserves. Within three years, if the deficit is not corrected, the City's reserves are forecasted to be



completely depleted. After that, the City is projected to operate with growing, unsustainable debt reaching nearly \$6 million by Fiscal Year 2023/2024, which is nearly half of the total General Fund budget of \$12.9 million. The City cannot operate with structural debt and would have to make deep service level reductions to balance the budget.

Measure Z is being placed before voters to prevent deep cuts and establish a sustainable City budget to support current service levels. Measure Z, if approved, would repeal the existing  $\frac{1}{2}$ -cent local sales tax and replace it with a  $\frac{1}{2}$ -cent local sales tax, raising the sales tax from  $\frac{9}{2}$  to  $\frac{9.75}{6}$ . The tax measure would generate \$3.3 million in total, with \$2 million of that in new revenues to the City. All funds would remain in the community to support local services.
